SUBJECT : UPDATED LISTS OF VISAS UPON ARRIVAL

This Circular serves to inform that Cabinet has approved the addition of Ghana to the list of countries whose Nationals benefit from Visas upon arrival in Namibia. Cabinet further approved the addition of the African Development Bank Group Laisser Passer Holders (Official and Diplomatic) to the list of institutions whose officials are exempted from Visa requirements for holders of diplomatic and official/service passports, when travelling to Namibia.

Given the above, Missions are herewith, kindly requested to share the information with relevant authorities in areas of jurisdiction. Please note that the implementation date of this decision will be announced in due course. Enclosed, please find updated list for perusal and ease of reference.
